PUBLIC PARTICIPATION IN JOINT OPERATING COMMITTEE MEETINGS</p> <p>The Joint Operating Committee recognizes the value to school governance of public comment on educational issues and the importance of involving members of the public in Joint Operating Committee meetings.</p> <p>The Joint Operating Committee shall establish guidelines to govern public participation in Joint Operating Committee meetings necessary to conduct its meeting and to maintain order.</p> <p>In order to permit fair and orderly expression of public comment, the Joint Operating Committee shall provide an opportunity at each open meeting of the Joint Operating Committee for residents and taxpayers of participating districts to comment on matters of concern, official action or deliberation before the Joint Operating Committee prior to official action by the Joint Operating Committee.</p> <p>The public shall be permitted a maximum period of one-half (½) hour prior to the Joint Operating Committee conducting the business on the agenda, for oral questions or comments pertaining to the evening’s agenda. Each person wishing to address the Joint Operating Committee during this period shall state his/her name and participating district.</p> <p>A second such one-half (½) hour period shall be afforded the public at the end of each meeting for general comments.</p> <p>If the Joint Operating Committee determines there is not sufficient time at a meeting for public comments, the comment period may be deferred to the next regular meeting or to a special meeting occurring before the next regular meeting.</p> <p>The presiding officer at each public Joint Operating Committee meeting shall follow Joint Operating Committee policy for the conduct of public meetings. Where the Chairperson's ruling is disputed, it may be overruled by a majority of those Joint Operating Committee members present and voting.</p>

<p>4. Guidelines</p>	<p>Whenever issues identified by the participant are subject to remediation under policies and procedures of the Joint Operating Committee, they shall be dealt with in accordance with those policies and procedures.</p> <p>Inquiries requiring a review of policies and/or statistics must be presented in written form since they cannot be answered out of hand and will necessarily require study and a reply at a future date.</p> <p>The Joint Operating Committee requires that public participants be residents of this Upper Bucks tri-district area or anyone representing a group in the community or school districts, any representative of a firm eligible to bid on materials or services solicited by the Joint Operating Committee, any employee or student of the technical school.</p> <p>Participants must be recognized by the presiding officer and must preface their comments by an announcement of their name, address, group affiliation if applicable, and topic to be discussed.</p> <p>No participant may speak more than once on the same topic, unless all others who wish to speak on that topic have been heard.</p> <p>All statements shall be directed to the presiding officer; no participant may address or question Joint Operating Committee members individually.</p> <p>The presiding officer may:</p> <ol style="list-style-type: none">1. Interrupt or terminate a participant's statement when the statement is too lengthy, personally directed, abusive, obscene, or irrelevant.2. Request any individual to leave the meeting when that person does not observe reasonable decorum.3. Request the assistance of law enforcement officers to remove a disorderly person when his/her conduct interferes with the orderly progress of the meeting.4. Call a recess or adjournment to another time when the lack of public decorum interferes with the orderly conduct of the meeting.5. Waive these rules with the approval of the Joint Operating Committee. <p>Electronic recording devices and cameras, other than those used as official recording devices, shall be permitted at public meetings under guidelines established by the Joint Operating Committee.</p>
