2021-2022 Parking/Driving Regulations

Driving to and from UBCTS is a privilege, not a right. Parking will be available for those students who achieve First Honors. Are NTHS (National Technical Honor Society) students. Students on Co-Op and Home School Students. A parking fee of \$10.00 will be collected once the application is completed and handed in. Cash or check payable to UBCTS will be accepted. When privileged to drive the following rules must be observed when driving or parking on school property. Failure to abide by these rules will result in a thirty day suspension of driving privileges for first offense and a permanent loss of driving privileges for second offense.

1. Any student who wishes to drive to UBCTS in a private vehicle must have a completed parking permit application signed by a parent/guardian and on file at UBCTS.
2. All registered vehicles must display a proper UBCTS registration tag. Tag is not transferable and cannot be used by another student
3. Students must arrive by 8:30 a.m. for First Session and 11:30 am. for the Second Session. PM Session students must arrive by 11:20 am if they are eating lunch at UBCTS
4. All vehicles must be operated in a proper and safe manner in accordance with PA Dept. of Transportation regulations. That includes driving to and from UBCTS and on school property.
5. Adhere to the speed limit which is five **(5) miles per hour**.
6. Vehicles shall not be used or entered during the lunch periods or during regular school hours, unless permission is given by an UBCTS staff member.
7. Loitering in cars before, after, or during school hours is prohibited.
8. All highway signs on school property are to be obeyed, at all times.
9. Vehicles are to be locked at all times.
10. Special care must be exercised by drivers of vehicles when buses are loading and unloading. Driving in the bus area is to be done cautiously, yielding to all buses and pedestrians.
11. All vehicles are to be parked in designated parking areas and parking spots. No parking is allowed in any other area.
12. Do **not** change a parking spot if yours is occupied. Report this to the main office.
13. The school shall not be held liable for any theft or damages to vehicles. Any incident of this nature must be handled by the individual(s).
14. Unauthorized vehicles on the school property are subject to prosecution and may be towed at the owner's expense.
15. School authorities have the right to search a student's car on school property.
16. Any incident of reckless driving reported by a school district bus driver or private citizen will be reported to the state and/or local police for disposition.
17. No passengers permitted
18. Drivers must report for their respective session on time. Students are to drive directly to UBCTS.
19. Smoking or cigarettes in plain view shall be subject to laws governing tobacco product possession.
20. Illegal substances or contraband in plain view shall be subject to disciplinary action of the school and/or legal authorities.

Failure to abide by these regulations may result in the indefinite suspension of driving privileges and the forfeiture of the parking fee.
