## UBCTS Student Driver Plan

Student drivers will be given the opportunity to drive to UBCTS for the 2020-2021 school year on a first come, first serve basis. Applications will be available online to print and bring to school August 25th, 26th, 27th, between the hours of 8am - 3pm. Student drivers must provide a copy of a valid driver's license, registration and insurance. If the paperwork is not submitted by August 31st by 3pm, students will not be allowed to drive to UBCTS (please remember that we have a limited amount of spaces available). The following students will be given seniority on driving to UBCTS for the 2020-2021 school year:

- Co-op Students
- Senior Students
- Junior Students

Student drivers will be charged \$10 and will be assigned a parking spot while given a UBCTS picard to place in their vehicle. The picard must be visible at all times and expire at the end of the school year. Sharing permits will not be permitted. This will result in an automatic suspension of driving privileges.

Student drivers will be allowed to take up to one passenger with them unless it is a family member; however, no more than three persons will be permitted per vehicle. The passenger must have written permission from their parent/guardian and the driver must have written permission from their parent/guardian for the passenger to be in their vehicle. The parent/guardian will email Mr. Gale ([dgale@ubtech.org](mailto:dgale@ubtech.org)) or Mr. Gentilezza ([cgentilezza@ubtech.org](mailto:cgentilezza@ubtech.org)).

All student drivers will be expected to arrive on time. If that student does not arrive on time, they will not be permitted into the building that day and it will be counted as an unexcused absence. A total of two (2) unexcused absences will cause the student to forfeit their parking spot. All student drivers must adhere to the timeframe for the safety of others and staffing here at UBCTS. AM session students must arrive no later than 8:20am, and PM session students no later than 11:20am.

By entering the parking lot, the student driving the vehicle is giving consent to a complete search of the vehicle by school officials or the police. UBCTS reserves the right to search any vehicle if reasonable suspicion exists to do so, with or without the presence of the student. The student will be held responsible for any prohibited objects or substances such as alcohol, drugs, and weapons that are found in said vehicle and may be subject to disciplinary action by UBCTS, as well as referred for criminal prosecution.

Any type of reckless driving (speeding, driving over curbs, etc.) on UBCTS property at any time (school day/non-school day) will result in automatic permanent loss of driving privileges. Leaving early or arriving late to miss lunch is prohibited. Students may not visit their vehicle during school hours unless it is for dismissal or given specific permission to do so. Students with driving privileges will be dismissed at 2:00pm.

**Failure to adhere to these rules will result in an automatic permanent loss of the student's driving privileges at UBCTS. No refunds will be given.**
